Region Director's Report | Kathy Singleton

It's been hectic since the fall election! I've attended two national board meetings on your behalf. I am your representative on the national EGA board, just like the region reps represent their chapters on the region board. I previously sent you a report on the fall national board meeting so I will not repeat it here. It is attached at the end of my report.

The spring national board meeting took place in Louisville on March 13-15, 2015 at the Galt Hotel. Friday morning started with the RD meeting. We were updated on all of the committee meetings that took place prior to the RD meeting. Friday afternoon started the board meeting which carried through all of the remaining time. Following are the highlights:

- 1. EGA currently continues to have 13 regions and the current chapter count is 289 with total national membership at 9508.
- 2. The national office only needs to know three of the chapter officers: president, treasurer and membership
- 3. There will be a change in registration for the upcoming seminars. Open registration will no longer go to a lottery. It will be first come, first served. Early registration will continue to be a lottery if needed. This will speed up the whole process of registration and make a number of items easier for all involved.
- 4. A discussion occurred about the EGA mission which is Education. And the business of EGA that supports that mission is the seminar. It is our major fundraiser.
- 5. The EGA attorneys that are working on the Gay Montague Phillips estate were in attendance and gave a report on the current status. EGA's share of the estate is \$1.4 to 1.9 million depending on which appraisal is used. The estate is a ¼ share of a family trust that involves many assets, tangible and intangible. The family would like EGA to not be a part of this trust and EGA does not want to be a part of the trust. So, the valuation is important as is whether or not the family can buy EGA's share in cash.
- 6. The annual meeting will be on Thursday October 29, 2015 at the annual national seminar.
- 7. Last year's seminar made a profit of \$100,000. Of that amount, \$44,000 goes to national and the balance is retained by PSR.
- 8. Youth programs were discussed and there continues to be progress on establishing this program.
- 9. Job descriptions at the national level were updated for the president, director of marketing, VP, national seminar director, and secretary.
- 10. The 2013 financial statements were accepted.
- 11. Travel and lodging for the national registrar elect, national seminar director and national seminar director elect were approved.
- 12. Responsibility for the President's Farewell event was placed under the VP position.
- 13. EGA now has a pinterest page. https://www.pinterest.com/ega_usa/
- 14. Between sessions motions included accepting the revised guidelines for chapter formation.
- 15. EGA's attorneys are continuing to work on EGA's renewal and expansion of our trademark.
- 16. There will be a youth exhibit in Louisville in the fall of this year, 2015.
- 17. The president was given approval to sign a new lease for the space in Louisville. The new lease is for 5 years and is at the same rent we are currently paying, \$2700 per month.
- 18. Work is continuing in the education department on a stitch guide.
- 19. Discussion was held about having a domestic teacher tour.
- 20. The revised RD notebook was made into two versions, normal and shortened. RDs will vote on which format they prefer.
- 21. Discussion was held about paying the writers and designers that contribute to NA.
- 22. Mandated bylaws changes were passed. See the report by our region bylaws chair.
- 23. Planning focused on how EGA can interest younger people. Topics included a larger web presence and a new form of membership.
- 24. The office staff and the EC all presented a summary of their jobs and responsibilities.

In addition to attending the board meetings:

- 1. Installed the officers at Central Florida Chapter
- 2. Attended a meeting of Suwannee Stitchers
- 3. Attended a stitching day with Neapolitan
- 4. Appointed and worked with a new roster chairperson, Jineen Kulczycky

- 5. Appointed a new education chair, Deby Talley
- 6. Sorted inventory and sent out listings and order forms for the region Ways and Means.
- 7. Helped education send in an application for the ITT for 2015.
- 8. Served on the 2015 and 2016 seminar committees.
- 9. Answered many emails about many things. I average 5 region emails a day. This does not include emails from national.

Bylaws Report | Adrienne Meyer

At the most recent national meeting in Phoenix, the board of directors mandated an amendment to Article IX Section 3 of chapter bylaws. [The underlining emphasis is mine.] At the March region meeting I will provide copies of the page for Sun board members to place in their notebooks.

Article IX Section 3

No one may profit from membership in EGA; however an EGA chapter may contract with individual members in their professional capacities. EGA prohibits the use of Membership lists other than for EGA purposes.

ARTICLE IX FISCAL POLICIES

- **Section 1.** The fiscal year shall be from January 1 through December 31.
- Section 2. The books and accounts of the chapter shall be kept in accordance with sound accounting practices. Chapter financial records shall be audited each year, either professionally or by an audit committee appointed by the chapter president. The treasurer shall furnish EGA with a report of the finances of the chapter by February 15 of each year and shall send proportionate amounts of each member's dues to both EGA and the region on a regular basis.
- Section 3. No one may profit from membership in EGA; however an EGA chapter may contract with individual members in their professional capacities. EGA prohibits the use of membership lists other than for EGA purposes.

Section 4. **Annual Budget**

- a. The chapter shall prepare and present a budget to the membership for approval no later than the meeting prior to the effective date of the budget.
- b. The board of directors and/or the executive committee shall not spend any non-budgeted funds in excess of \$_____during the budget year. The chapter may approve an expenditure in excess of this amount provided:
- 1. the membership is notified in writing at least thirty (30) days prior to the meeting at which the vote is taken,
- 2. the written notice shall include the amount and purpose of the expenditure, and
 - 3. the approval is by a two-thirds vote.
- Section 5. Donations: Donations of monies by the chapter may be made to any organization which is in compliance with Section 501(c)(3) of the United States Internal Revenue Code and which the chapter, by a two-thirds vote has designated as the recipient. Notice of such a proposed donation shall be submitted in writing to the members at least thirty days prior to the meeting at which such vote is to be taken.

Section 6. Dissolution: In the event of dissolution of the chapter, all its assets and funds remaining after payment or provisions for payment of all debts and liabilities of the chapter shall be distributed to one or more organizations which have been in existence for a period of two years, which are in compliance with Section 501 (c) (3) of the United States Internal Revenue Code, and which the chapter has designated as a recipient by a twothirds vote. Notification to the membership shall be provided in writing at least thirty days prior to the meeting at which such a vote is to be taken.

Education Report | Cheri Hammer/Deby Talley

Your education committee has been busy, busy! As you know, last fall Sun Region brought in Alison Cole as part of the International Touring Teacher (ITT) program, and the class was a resounding success! In fact, it went so well that the region is once again applying for an international teacher in conjunction with the national seminar, so stand by for further information when it becomes available.

In addition to the ITT program, the region also provided a \$1000 scholarship opportunity for a lucky Sun Region member to attend the 2015 International Embroidery Conference (IEC), Threads through Time. We had very good participation, and the competition was very close. The scholarship winner was Donna McFarland from the Indian River Chapter! We look forward to her article on the conference in an upcoming edition of Sun News, and to her presentation at a Sun Region meeting.

Another activity since the last Sun Region meeting was submission of a proposal to national for the Gay Phillips Education Grant. We were successful with our proposal, so we will receive \$5000 to be used toward bringing touring teacher(s) into the region and offering classroom opportunities to all members within the region. The classes/lectures will be held in multiple geographic locations throughout the region to maximize availability to Sun Region members. This activity is still in the planning stages.

And don't forget there is still a \$200 education grant available to all chapters during this calendar year. It was approved that the educational opportunity can be something other than a GCC or a workshop – just be sure to get it pre-approved. Details for grant application are available on the Sun Region website.

Finally, this will be my last meeting as Education Chair. Deby Talley is your new Education Chair, and she brings a wealth of knowledge and talent to this position. She will do a great job for you!

Biscayne Chapter: Habitat for Humanity of Greater Miami will dedicate ten homes on February 28, 2015 at their Blitz Build Dedication Celebration. We congratulate the partner families who received the keys to their homes and our personalized Habitat Samplers. We have stitched and personalized 12 samplers already in 2015.

Our members continue to stitch Soldier Family Kissing pillows; knit or crochet caps for pediatric oncology patients; and collect stamps, coupons for education, pop-tops, pennies, and toiletries.

Canopy Oaks Chapter: SIP was held on Valentine's Day.

Central Florida Chapter: Our chapter had great member participation in this year's Stitch in Public Day on Saturday, February 7th. A total of 11 CFC members stitched at 5 local library branches in Orange and Seminole Counties. 2015 Chapter Stitching Project – Breast Cancer Ribbon Bookmarks:

Our 2015 project is stitching Breast Cancer Ribbon bookmarks to donate for women receiving chemotherapy at our local Orlando hospitals and cancer centers. The pattern can be found at

https://kincavelkrosses.wordpress.com/2011/10/01/think-pink-bookmark/ and is designed exclusively for Breast Cancer charity fund-raising or to donate.

We started putting notices for our General Monthly Meetings in the "What's Happening" section of the Thursday and Sunday editions of Orlando Sentinel Newspaper. This is a free service provided by the newspaper. Hopefully, these regular notices will let everyone know that needlework is alive and well in the Orlando area.

We are working with Jo-Ann's Fabric stores to arrange Needlework Demonstration days throughout the year. Joann's will allow groups like ours to use their craft rooms, when they don't already have scheduled classes. The events will be set up on Saturday mornings when the stores are full of people. We will have members working on various projects to show the diversity of the Guild and will pass out flyers to make crafters aware of our Chapter.

Chain Stitchers Chapter: Our main outreach initiative continues to be through Habitat for Humanity. Their dedication season usually starts in the late spring—right now they're busy building things (and we're busy stockpiling samplers). We recently learned that our local Habitat affiliate is going to do something innovative. They're going to develop a "brownfield" site in my city as a "re-entry" community for returning military and veterans. They envision a compact group of bungalows where families can reside while they're grounding (or regrounding) themselves in the larger community. Since the families won't own their bungalows, our traditional samplers aren't really "on target." I'm going to set up a meeting with the affiliate leader to work out some larger-scale item that we can present at the community dedication. We'll also talk about what sort of commemoration might be appropriate when a family leaves the "re-entry" community, since in most cases they won't be going into Habitat housing. It's very exciting!

Chain Stitchers stitched-in-public at the Saturday morning Leesburg Market this past weekend. We had a good location and drew moderate attention, but we're not sure that we were productive membership-wise.

We've begun to wonder if we might have better luck speaking with some of the local home-school curriculum coordinators.

I don't know if you ever met Diane Atkins. She was active in the region during the mid-2000s and she was also a past-president of our chapter. After her death last summer, the presentation quilt the chapter had made for her was returned to us. After discussion, the chapter has decided that we'd like to donate it to our local hospice organization or, failing that, to a local cancer-treatment center.

Gulfview Chapter: Gulfview chapter has been very busy lately. Back in November through December our members had a very successful exhibit of our needlework at the Pasco Hernando State College gallery in New Port Richey. We also had several members attend the Senior Expo at the college in January to explain our chapter's purpose and to attract possible future members. Our Stitching in Public Day was held on Saturday, February 28th, at the Regency Park Library. We also had a mini exhibit of smaller pieces in the display case at the library in January.

We continue the EGA sponsored projects of stitching kissing pillows for the military and their families as well as Habitat for Humanity samplers. Many of our members have knitted, crocheted or quilted blankets for the ongoing Linus Project.

Indian River Chapter: Kissing Pillows: We took 104 completed pillows to Patrick Air Force Base in December. Currently, we have made kits for all members to stitch. We will advise when we send another supply to the Base.

Military Outreach: On February 9, 2015, 47 kits and 27 hoops were contributed to the Viera Veterans Clinic. We are collecting more and look forward to member participation.

Each year we have collected toiletries for the Daily Bread initiative in Melbourne with a goal of 2000 items. For several years in a row we have surpassed our goal and are already up to 881 items which is 44% of our 2015 goal. We are planning on increasing our goal number.

Habitat for Humanity: We have reached 277 samplers for the Habitat houses. This number is during the last several years. In 2014 there were 14 new houses built which have our samplers. There are 5 in the works so far for 2015.

Library Exhibits: We currently have an exhibit in the Melbourne Library on Fee Avenue. This will be followed by a beading exhibit in the Suntree/Viera Library in March. In June we will have an exhibit at the Satellite Beach Library and are scheduled for November in Malabar Library.

Teaching Adults: We are in discussions with an assisted living facility in Melbourne to teach the adults who have shown an interest in learning. Dates are not firm yet.

Neapolitan Chapter: Neapolitan Chapter continues to support Habitat for Humanity with their stitched samplers.

Sand Dollar Chapter: Sand Dollar Chapter stitched in public at Hobby Lobby in Daytona on Feb 7 but received little interest from shoppers and are reevaluating the location for next year.

Sand Dunes Chapter: Sand Dunes Chapter participated in the Stitch in Public day at Books a Million. We had a few ladies stop but no real interest in joining us. Our outreach project for this year will be the same as last year - Christmas stockings given to Children's Advocacy Center. We will have a workshop in March to make the stockings and then will start handing them out at our May meeting for members to stitch a Christmas motif on the "bibs".

Sarasota Chapter: Sarasota Chapter has been doing free stitch- ins at the Jacaranda Library in Venice. On the 7th beading and on the 14th we had a needlepoint session. I believe they had 10 participants. On the 21st they are doing cross stitch and on the 28th, Silk ribbon. They had to sign up early and the class was limited to 10. Teachers were volunteers and usually 3 angels to help. The projects were small as the class was from 10:00- 1:00. We also had a display of all the techniques set up on the 2nd of Feb in display cases. The library did some notices of our offerings. It has been very successful and we hope to get some new members. Every Christmas we collect goodies (soaps, cosmetics razors, etc.) for Bethesda House in Sarasota (low income housing).

Sea Grape Chapter: Sea Grape Chapter held a Needle Art Exhibit Feb. 12-14 in celebration of its 40th anniversary. About 100 pieces of needlework were on display as well as other related booths. One table displayed a large announcement of the number of baby caps and chemo caps that the chapter donated in 2014 to Lee Memorial Hospital as our Outreach Program. Samples of the various caps were arranged around it along with a sheet showing the total number of hours devoted to this project by each knitter. It stated that we donated 236 chemo caps, 243 baby caps, for a total of 1895 hours in 2014. The last line pointed out that since this Outreach Program began in 2000, Sea Grape Chapter has donated 14,753 hours of volunteer knitting for our local hospital.

Biscayne Chapter | Schelley Iman-Loch

Since October 2014, the Biscayne Chapter has undergone fundamental changes in its procedures and structure. Biscayne Chapter embraced the recommendation of EGA National and elected only three officers to the executive board in November 2014: President, Secretary and Treasurer. The President will also act as the Region Representative as well as take on the administrative responsibilities of the Vice-president. Chairwomen were appointed to the Programs and Education committees.

Besides the reduction in the number of officers, we began our examination of the procedures and structure of our chapter by creating a new format for the newsletter. It is a template that will be used for the general, business and board meetings as well. Sea Grape Chapter | Betty Baechle


The 40th anniversary of our chapter was celebrated during our November meeting. There was a special display of some of the past class projects. Fun to see what we learned so many years ago.
