3. "Stitch A Waves" registration does **NOT** reserve your room aboard the RCCL Utopia. See below for information on how to book with **Daphne Lacy at Travel by Ginny**. All block cabins **MUST** be booked thru Ms. Lacy to get the block price and for Sun Region to be credited with the booking. This allows us to have the dedicated stitching room! The only Sun Region add-on fees for this cruise is the Registration Fee. **Remember to mention allergies, dietary restrictions, and mobility issues!**

OTHER IMPORTANT INFORMATION:

1. **Mid-April 2027, any unsold cabins in the block will be released back to RCCL. DO NOT DELAY—book your cabin and make a deposit as soon as you can determine that you will attend Sun Region’s “Stitch a Waves”.**
2. **Final Cruise Payment is DUE on July 1st, 2027.** Check your cruise reservation documents.
3. **We highly recommend travel insurance.** You do not have to use Royal Caribbean’s, there are many others. Daphne can make recommendations.
4. **Registration Checks** must be payable to **"Sun Region - EGA"** and mailed to Stephanie Murphy, Registrar, 2142 New York St., W. Melbourne, FL 32904.
5. **ALL FEES must be paid on or before June 1, 2027.** You will be billed for any fees that remain unpaid as of June 30, 2027.
6. **REGISTRATION IS ON A FIRST-COME, FIRST-SERVED BASIS.** YOUR SUN REGION “STITCH A WAVES” REGISTRATION IS NOT CONFIRMED UNTIL YOUR REGISTRATION FEE IS RECEIVED.

CRUISE INFORMATION

1. Sun Region has reserved 30 cabins, 10 of each type listed below. First come, first served. More cabins may be added to the Sun Region Block if we fill the existing block.
2. You **MUST** have a US Passport (or your country’s Passport if you are not a US citizen) to travel to the Caribbean. If you are not a US citizen you may need visas. If you do not have these documents, you should start the process to acquire them as soon as possible. Talk to Daphne.
3. Again, you must reserve thru Daphne Lacy to receive the pricing below and to credit us enough cabins to have a dedicated stitching room. If you have any problems, don’t hesitate to talk to Daphne. Remember to talk about dietary restrictions, mobility issues, travel concerns.
